MINUTES APPROVAL

NEGOTIATIONS UPDATE

L.S. explains that if both sides cannot come to an agreement, we will end up at impasse.

ECCE:

- Article 6—Salary Increases
- Article 6 (New section)—Longevity Increases
- Article 9 (Sections 4, 5 & 6)—Classification Review Process, appeal and unit review
- Article 11 (Section 2(c)—definition of "Immediate Family" Add aunt, uncle, niece, and nephew
- Article 11 (Section 10(f)—District will grant "paid" leave For judicial or official appearance
- Article 15—Medical Benefits

*Salary increases—5% retro back to January 1, 2017 1% or COLA whichever is higher for 2018 COLA for 2019

*Longevity—2% at 10, 15, 20, 25 to begin July 1, 2017

*Assuming the 5% increase, if you make \$4,140/mo (Range 20), this would be an approximate monthly longevity increase:

At 10 yrs. – 83.00 At 15 yrs. – 167.00 At 20 yrs. – 253.00 At 25 yrs. – 341.00 *We will let go of any increases to medical benefits, the classification review, language for the additions to the "immediate family" definition, add "paid" leaves to Article 11 Section 10(f), and removal of the district's OT proposal and holiday pay proposal.

District's most recent longevity offer:

10 yrs. - \$50 20 yrs. - \$125 25 yrs. - \$200

Toni Newman asks if the district is taking the Issue of not paying employees before or after a holiday off the table? L.S. responds that it seems like they are.

M. Whiting states that she would like to add the 15-year longevity increase to the district's offer.

Cindy Lopez states that she would like to either have the longevity package be better, or have the district increase the medical benefits cap.

Maricela Vital would like the negotiations team to fight for the cap on benefits to increase.

L.S. presented \$100 gift cards to the outgoing E-Board: Angie Gardea, Lavonne Plum and Priscilla Baldwin.

L. Dawdy goes up to thank Luukia Smith for her 16 years of service to ECCE as President.
